

**DIRECTIONS TO THE MOYNAHAN LAW FIRM, LLC

FROM I-84 EASTBOUND (NEW YORK CITY, DANBURY):

1. Take I-84 East to Exit 22 in Waterbury.
2. Turn left at lights at end of ramp onto South Main Street.
3. Go through four (4) sets of traffic lights (past the Green). At the Green, South Main Street becomes North Main Street.
4. Take the first right after the Green onto Phoenix Avenue.
5. Take the first right into parking lot.
6. Enter the double set of brass doors and take the elevator to the second floor.

FROM I-84 WESTBOUND (HARTFORD):

1. I-84 West to Exit 22 in Waterbury. Take a left at lights at end of ramp onto Union Street.
2. At fourth set of traffic lights on Union Street (Wachovia Mortgage Company & Webster Bank will be on your right), take a right onto South Main Street.
3. Go through three (3) sets of traffic lights (past the Green). At the Green, South Main Street becomes North Main Street.
4. Take the first right after the Green onto Phoenix Avenue.
5. Take the first right into parking lot.
6. Enter the double set of brass doors and take the elevator to the second floor.

FROM ROUTE 8 SOUTHBOUND (TORRINGTON):

1. Route 8 South to Exit 32 (Riverside St) in Waterbury (left exit, just before 84 East exit).
2. At the end of the ramp at the light, take a left onto Freight Street.
3. Go to the end of Freight Street and take a left onto Meadow Street.
4. At the next light, take a right onto West Main Street.
5. Go to second light and take a left around the Monument Rotary so that the Green is on your left.
6. Go to end and take a left onto North Main Street.
7. Take the first right onto Phoenix Avenue.
8. Take the first right into parking lot.
9. Enter the double set of brass doors and take the elevator to the second floor.

FROM ROUTE 8 NORTHBOUND (BRIDGEPORT):

1. Route 8 North to Exit 32 (Riverside Street) in Waterbury
2. At the end of the ramp at the light, take a right onto Freight Street.
3. Go to the end of Freight Street and take a left onto Meadow Street.
4. At the next light, take a right onto West Main Street.
5. Go to second light and take a left around the Monument Rotary so that the Green is on your left.
6. Go to end and take a left onto North Main Street .
7. Take the first right onto Phoenix Avenue.
8. Take the first right into parking lot.
9. Enter the double set of brass doors and take the elevator to the second floor.
